- I. The meeting was called to order by Vice-Chairman Richard Smith. Virginia Hart led the Pledge of Allegiance.
- II. Guests were welcomed and everyone introduced themselves.
- III. The Agenda was presented. Rod Cury made the motion to accept the agenda, seconded by Virginia Hart. The agenda was accepted.
- IV. Minutes from the April 17, 2019 and June 4, 2019 meetings were distributed. Rod Cury made the motion to approve the minutes, seconded by Virginia Hart; the minutes were approved.

### V. New Business:

1. Jerry Dunford came before the Commission with a request to add campgrounds to the R-2 zone. He is seeking to develop a campground on his property on Birmingham Road. Tim Taylor explained the wide range of uses for R-2 and a little of the history behind that zoning classification. Mr. Dunford shared details of his proposed campground: acreage, number of campsites, utilities, and the background work that has been done. He would like to start work on the campground in October

2019 with a projected opening in Spring of 2020. He is interested in attracting families and ATV riders. Richard Smith then led the discussion of the possibility of zoning the area A1 Agricultural because of the location and mixed use there. Others agreed with that point. Richard Smith then made the recommendation to re-evaluate the Birmingham Road area and reclassifying the zoning to agricultural at the September meeting. He also invited Mr. Dunford to return and bring a more detailed map of his proposed campground and his request will be placed on the agenda for that meeting.

- 2. The meeting then turned to a review of the Clinch River Walking Trail Project.
  - Rick Chitwood and Greg Widener from Thompson and Litton had brought a detailed diagram of the proposed trail for everyone present to review.
  - Mr. Chitwood reported that the Preliminary Engineering Report (40% Review) is ahead of schedule; they have an October target for its completion. He provided an updated Proposed Project Schedule showing the tasks and target dates. \*See attachment.
  - Mr. Widener gave Trail updates and walked us through the diagram from Critterville to the Richlands Mall. Those in attendance were encouraged to ask questions and provide feedback.
  - A round table discussion was then held on the next steps. Mr. Chitwood recommended no more than three phases now due to funding. He shared a Probable Project Cost estimate emphasizing that this was to create the most ideal trail with all components. \*See attachment. He also provided a handout of Potential Funding Sources and others present contributed additional ideas: local corporations, local businesses, funding from small sources/grants. \*See attachment.
  - Mr. Chitwood will return in October with the project broken into the three phases and a plan for completion of these.
- VI. With no further business to discuss Rod Cury made the motion to adjourn and Virginia Hart seconded the motion. Meeting adjourned with the next scheduled meeting date of September 3, 2019 at 7:30 PM.
